Both parties agreed to cooperate with the provisions stipulated in the following articles:

#### Article 1

Both parties agreed to establish cooperation in the fields of education, research, and community service.

#### Article 2

General Provisions For Implementing Cooperation

This collaboration is based on the intention to mutually benefit both parties which will ultimately contribute to the advancement of science and technology that is beneficial to society, the nation and the State.

#### Article 3

Cooperation Objective

Cooperation between the First Party and The Second Party aims:

- a. Improving the quality of Human Resources in the fields of education, research, and community service in the Walisongo State University Semarang and SLL & CS Center for Chinese & Southeast Asian Studies, JNU, New Delhi.
- b. Promote cooperation in the field of education, research, and community service, according to the mission of both parties.
- c. Encouraging the improvement of the performance of both parties in their role to prosper and educate the community.

## Article 4 Form of Cooperation

The First Party and The Second Party will collaborate in the fields of education, research, and community service in detail in the form of:

- a. Exchange of experts or teaching staff, scientific meetings, community service activities and various scientific activities at the Masters (Doctoral) and Doctoral (S3) level.
- b. Exchange program publishing research works for S2 and S3 students.
- c. Program to improve the quality of human resources for teaching staff and administrative staff.
- d. Other scientific programs deemed necessary by both parties.

### Article 5

Financing

The funding required as a result of the implementation of the agreed program of activities will be borne by both parties, based on their respective capabilities, and insofar as they do not conflict with applicable laws and regulations.

#### Article 6

Time Period

This collaboration is valid for 5 (five) years from the signing of this agreement, and can be extended in accordance with the agreement of both parties.

#### Article 7

- a. The follow-up of the implementation of this collaboration in the form of conception and operational activities and its implementation is regulated in a separate agreement, in accordance with the objectives of the implementation of the task.
- b. The text of this collaboration does not affect the development efforts of each institution in carrying out its duties and functions.
