



MEMORANDUM OF UNDERSTANDING

BETWEEN UNIVERSITAS ISLAM NEGERI (UIN) WALISONGO SEMARANG - ANDASIAN LAW GROUP PTY LTD

THE IMPLEMENTATION OF TECHNICAL ASSISTANCE FOR CURRICULUM REFORM AND COOPERATION

The Asian Law Group Pty Ltd (ALG) of Melbourne, Australia, and UIN Walisongo Semarang, of Central Java, Indonesia, hereby agree to establish cooperation to improve the quality of the curriculum offered to the students by UIN Walisongo Semarang.

PURPOSE AND OBJECTIVES

Article 1

- The purpose of these Terms of Reference for Cooperation is to acknowledge the shared purpose and intent of the Parties with respect to a program to improve the quality of the curriculum offered by UIN Walisongo Semarang.
- Expected program outputs are a curriculum review report containing recommendations to UIN Walisongo Semarang on how to improve its curriculum and pedagogy practices, to better meet global standards of tertiary education excellence.

ACTIVITIES CONTEMPLATED BY ALG

Article 2

To support the cooperation referred to above, activities that ALG intends to undertake include:

 Providing technical experts/consultants who will provide assistance to the UIN Walisongo Semarang by conducting a curriculum review of the Syariah and Tarbiyah Faculties and preparing a curriculum review report. 2. Training for selected UIN Walisongo Semarang staff to improve their teaching capacity and pedagogical practices.

ACTIVITIES CONTEMPLATED BY UIN WALISONGO SEMARANG

Article 3

To support the delivery of this technical assistance, UIN Walisongo Semarang is responsible for :

- 1. Coordinating with ALG and its staff to ensure their cooperation runs smoothly and required support is provided.
- Providing human resources and facilities to support planning and implementation and monitoring and evaluation activities for the ALG program.

DURATION

Article 4

- This Terms of Reference will apply from the date hereof until submission to UIN Walisongo Semarang of a curriculum review report prepared by ALG or any monitoring or evaluation required by ALG, whichever is later.
- Either party may terminate this Terms of Reference by providing written notice to the other party.

OTHER PROVISIONS AND CLOSING

Article 5

- The parties acknowledge that these Terms of Reference are intended to be a nonbinding statement of intent and agreement in principle to cooperate.
- 2. Nothing in these Terms of Reference is intended to impose an obligation of funds on either party or on any government.
