MEMORANDUM OF UNDERSTANDING

BETWEEN

UNIVERSITAS ISLAM NEGERI WALISONGO

ON FRIENDSHIP AND COOPERATION, PROMOTION OF MUTUAL UNDERSTANDING, ACADEMIC, CULTURAL AND ISLAMIC THOUGHT AND PERSONNEL EXCHANGE

This Memorandum of Understanding ("MoU") is executed

BETWEEN

INNOVATIVE UNIVERSITY COLLEGE (hereinafter referred as 'IUC'), a private university college whose address is at Unit GL35, Main Lobby, Block C, Kelana Square, Jalan SS7/26, 47301 Petaling Jaya, Selangor, Malaysia with SAADAH EDUCATION GROUP (hereinafter referred as 'SEG'), a registered company established under Companies Act 1965 the whose address is at B-3-3-5 & B-3A-5, Blok 3 Jalan Teknologi, PJU 2/1B, Seksyen 2, Kota Damansara 47810 Petaling Jaya, Selangor, Malaysia (both organisations hereinafter referred as 'IUCSEG') and shall include its lawful representatives and permitted assigns;

AND

UNIVERSITAS ISLAM NEGERI WALISONGO (hereinafter referred to as "the University"), an Islamic institution located in Semarang, Indonesia.

(Hereinafter referred to singularly as "the Party" and collectively as "the Parties")

WHEREAS

- A. IUCSEG is an educational institution both registered and working together with a track record of educational excellence and with a dynamic program of collaborative arrangements with many local & international counterparts.
- B. The University is an established Islamic institution with a track record of educational excellence.
- C. The Parties are desirous of entering this Memorandum of Understanding to declare their respective intentions and to establish a basis of cooperation and collaboration between the Parties upon the terms as contained herein.

NOW THIS MOU WITNESSES AS FOLLOWS:

ARTICLE 1:OBJECTIVE

The Parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulations and national policies from time to time in force in Malaysia, shall endeavor to strengthen, promote and develop academic, and research co-operation between the Parties on the basis of mutual benefit.

ARTICLE 2: AREAS OF COOPERATION

- Both parties agree to encourage the following activities, in particular, to promote cooperation in the following areas:
 - a) providing clear educational pathways for students of Islamic knowledge from secondary level to higher levels;
 - b) promoting students to pursue their study for higher levels under IUCSEG;
 - staff mobility program within both Parties through outbound / inbound program or other suitable medium;
 - training for academic enhancement or research related activities to student and staff of both parties;
 - e) student mobility program for academic and research-based activities;
 - technical collaboration in symposia, conference, short course or research meetings organized by the Parties;
 - g) knowledge exchange in teaching, career development and research opportunities; and
 - cooperation in any other areas as agreed by the Parties from time to time.
- 2. For the purpose of implementing the co-operation in respect of any areas stated in Article 2(1) the Parties may enter into agreements subject to terms and conditions as mutually agreed upon by the parties including clauses on "confidentiality", "suspension" and "settlement of disputes".

ARTICLE 3:FINANCIAL ARRANGEMENTS

- This Memorandum of Understanding shall not give rise to any financial obligation by one Party to the other.
- Each Party shall bear its own cost and expenses in the implementation of this Memorandum of Understanding.

ARTICLE 4: EFFECT OF MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create, any legally binding or enforceable obligations, express or implied, under domestic or international law.

ARTICLE 5:NO AGENCY

Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or so to constitute either party as the agent of the other.

ARTICLE 6:ENTRY INTO EFFECT AND DURATION

- This Memorandum of Understanding shall become effective as of the date
 of signatures of both parties, or if the dates vary, then the date of the later
 signature.
- This Memorandum of Understanding shall remain in effect for a period of 10(TEN) years.
- This Memorandum of Understanding may be extended for such a further period as may be agreed upon in writing by both parties.
- If this Memorandum of Understanding is not renewed by mutual consent, this Memorandum of Understanding will expire on the prescribed period or all activities will be finalized.

ARTICLE 7: REVISION, CHANGE AND AMENDMENT

- One of the parties may apply for a written review, revise, amend or modify in whole or in part of the Memorandum of Understanding.
- Any changes, revisions or amendments to the Memorandum of Understanding mutually agreed by both Parties shall be done in written form and is/are included as part of the Memorandum of Understanding.
- All revisions, changes and amendments shall take effect on the date agreed by both Parties.
- Revisions, changes and amendments shall not prejudice the implementation
 of any project, activity or cooperation arising from this Memorandum of
 Understanding before or at the date of the review, changes and amendments
 take effect.

ARTICLE 8:TERMINATION

This Memorandum of Understanding may be terminated by either party with a minimum of THIRTY (30) days written notice. Activities in progress at the time of termination of this Memorandum of Understanding shall be permitted to conclude as planned unless otherwise agreed.

ARTICLE 9:NOTICES

Any communication under this Memorandum of Understanding shall be in writing in the English language or Malay and delivered by registered mail to the address or sent to the electronic mail address of IUCSEG or the University as the case may be, shown below or to such other address or electronic mail address as either Party may have notified the other Party and shall, unless otherwise provided herein, be deemed to be duly given or made when delivered to the recipient at such address or electronic mail address or facsimile number which is duly acknowledged:

ARTICLE 11:SUSPENSION

Each party reserves the right to suspend the implementation of the Memorandum of Understanding temporarily, in whole or in part, for the purpose of preserving national security and interest, maintaining public order or protecting public health and safety. The suspension will affect immediately after the notification has been provided to the Party through diplomatic or authorized channels.

ARTICLE 12:ARBITRATION

In the event of any difference and dispute between the parties relating to the interpretation, implementation and / or application of the provisions contained in the Memorandum of Understanding shall be settled by joint consultation and between the Parties through the diplomatic channel without reference to any third party.

ARTICLE 13:COST OF STAMP DUTY

Each Party shall bear its own cost and related expenses rise due to the preparation of this Memorandum of Understanding.
